FOREST PRODUCTS WEEK ESSAY CONTEST

To celebrate *National Forest Products Week* (October 14-20, 2018) the **Idaho Forest Products Commission** sponsors a statewide essay contest. Encourage students to enter the contest to learn more about Idaho's forests, build vocabulary and work toward mastering Idaho Core Standards. *Cash prizes for the winning writers and their classrooms!*

Who may enter? All K-12 students in Idaho are eligible for the contest.

What are the requirements?

- ✓ See next page for Background Statement, Writing Prompts & Scoring Criteria.
- ✓ Each essay must include student name, teacher name and email, grade, school name and town.
- ✓ Teachers: <u>Submit only the top five essays per class</u>. If you send more than five per class, the judges are unable to review your essays. *Please include a list of <u>all</u> students who complete an essay, so we may provide a Certificate of Participation for every student*. Teachers with multiple sections of a class may send the top five essays per class section.

<u>What are the prizes?</u> Each winning essayist receives a certificate and a cash prize (K-2 \$25; 3rd-5th \$50; 6th-8th \$75; 9th-12th \$100). Their classroom receives \$100, and their teacher receives a voucher to attend a Project Learning Tree workshop, plus posters and other resources. There <u>is</u> a string attached: The winning essayist must help decide how the class spends its cash award! Honorable mentions are named at each level. <u>Every student receives a Certificate of Participation</u>.

When are the essays due? Essay submissions must be emailed or postmarked by 11/2/18.

BACKGROUND STATEMENT

Forests and trees provide many things—clean air and water; beautiful places to play and relax; homes for birds, fish and other wildlife; carbon storage; energy savings and numerous products for people. One of the best things about trees is that they are a renewable resource. When trees are harvested, new ones grow or can be planted. With sustainable forestry practices, our forests can continue to provide their many benefits for generations to come.

WRITING PROMPT for Grades K-5

Think about your daily life. Write an essay to a general audience sharing how tree and forest products touch your life, and why they are important to you. You may choose to consider one forest product, or a variety of products. (K-2nd graders may use any media for their "essay.")

WRITING PROMPT for Grades 6-12

Consider the merits of using wood versus other building materials. Write an essay to a general audience sharing your ideas, supported by your research, about whether using wood for building is a good choice environmentally and economically or not.
